OUR LONG-TERM VISION IS TO END ISOLATION THAT LEADS TO SUICIDE AND HELP MAKE SUSTAINABLE AGRICULTURE THE NORM. WE COMBINE MILITARY VETERAN REINTEGRATION WITH SUSTAIN AGRICULTURE INITIATIVES.

FARM-TO-MARKET PROGRAM: IN 2016, OVER 350 OF OUR VETERAN AND COMMUNITY VOLUNTEER MEMBERS (60% VETERANS, 40% FAMILY MEMBERS, AND COMMUNITY SUPPORTERS), PRODUCED 45,650 POUNDS OF FOOD, DISTRIBUTING MOST OF IT THROUGH OUR FARMERS MARKET STAND AT THE REGIONAL VA HOSPITAL IN SEATTLE, WA; THE FIRST OF ITS KIND IN THE NATION. WE DONATED 11,080 POUNDS OF ORGANIC VEGETABLES TO LOW-INCOME VETERANS, LOCAL FOOD BANKS, AND ORGANIZATIONS WHO FEED THE HOMELESS. WE HOSTED 208 EVENTS ACROSS THE PUGET SOUND REGION FOR A TOTAL OF 3,500 VOLUNTEER HOURS. WE ALSO HOSTED TWO PEER SUPPORT TRAINING EVENTS TRAINING 44 PEER SUPPORTERS FROM ORGANIZATION AROUND THE COUNTRY, EMPLOYED 9 VETERANS, AND TRAINED 6 INTERNS. IN 2017 WE ARE DOING EVEN MORE.
