

**1** Briefly describe the organization's mission:

(See Part 1, line 1) Using the farm as the catalyst, we provide opportunities for military veterans to learn new skills, engage with the broader civilian community, and provide each other with peer support. Our programs address veteran isolation, a root cause of many issues facing the veteran population; including suicide, unemployment, homelessness, and divorce. By working to create a culture of supportive practices, our mission is focused on long-term prevention of, rather than reaction to, the issues mentioned above.

**Farm-to-Market Program**

Our Farm-to-Market Program serves as the platform for all of our program activities. Our 500+ veteran and volunteer members work alongside each other to raise organic produce and distribute it to veterans, caregivers, and community members throughout the Puget Sound region. Together we raised 32,000 pounds of food and donated 6,200 pounds of food to food banks and organizations that feed the homeless. We hosted 137 separate volunteer events throughout the year, with a total of 556 volunteers and 4,296 volunteer hours. Based on the National Standard of \$23.07 per volunteer hour, this equates to an economic impact of \$101,415 in volunteer support for our mission. We are proud to be able to use our farmers market stand at the Seattle V.A. Medical Center to share our mission with thousands of veterans each year and to strengthen our organizational connection with the federal Department of Veterans Affairs.

**Outpost Program:**

Our Outpost Program has been a pilot to help us determine the feasibility of replicating our model in other areas. Our 2015 Outpost activities contributed to the Farm-to-Market outcomes above, and helped us determine the future of our Outpost program. From 2016 onward, we will be designing a robust training program called the Growing Veterans Outpost Training, which will share the Growing Veterans model and best practices in implementing our model, to veteran farmers, non-profits, and community groups from around the United States.

**Peer Support Program:**

Our Peer Support Program has historically been informal in nature, acknowledging the negative stigma that the veteran population tend to place on seeking help (confirmed by a wealth of research data that is publicly available). Over the course of 2015, our veteran staff, along with licensed mental health providers and education professionals, designed an innovative Peer Support Training program that is designed to create a culture of peer support. From 2016 onward, the Peer Support Training will train Growing Veterans members and regional veteran service provider stakeholders, in order to create a strong culture of peer support and teach individuals the knowledge, skills, and awareness required to be highly skilled peer supporters. Additionally, 70% of our staff members were trained and certified in Applied Suicide Intervention Skills Training, and we intend to acheive 100% certification by the end of 2016 and onward.
